STRATEGY 1: K-12 Guaranteed & Viable Curriculum (GVC)

Activity 1

K-12 Building-Level PLC Teams Will Establish a GVC Unit by Unit with Coaching Support from CITS, LAS, LITS, & MRIS

Components Include:

- Essential Standards
- Identify Learning Targets
- Create *I Can* Statements
- Determine Proficiency Levels
- Determine Strategies & Pacing

Monitoring Options:

- GVC Surveys (PLC Tight, Right, etc. & Pathways from Energize)
- Completed Unwrapping Templates (Includes the 5 Components of a GVC)
- Evidence of Students Progress-Monitoring Utilizing *I Can* Statements
- Evidence of Team Consensus on Proficiency Levels of Essential Standards
- PLC Agendas

- Analyze CA Data
- Analyze Effectiveness of Instructional Practices

- CAs & CA Data
- Evidence of Team Data Analysis
- Data Protocols
- Exemplars of Student Work

STRATEGY 4: K-12 Multi-Tiered System of Supports (MTSS)

Activity 1

K-12 Building-Level PLC Teams Will Ensure Equitable Interventions & Extensions for ALL Tiers with support from CITS, LAS, LATs, LA Admin., LITS, MRIS, MTSS Admin., MTSS Facilitator, Sheltered EL Teachers, & Title 1 Teachers

Components Include:

- Interventions & Extensions (Do Not Take Place During Tier 1 Instruction)
- Regroup Students for Tier 2 Interventions & Extensions
- High Dosage After-School Tutoring
- Tier 3 Interventions Offered to Students Who Lack Essential Prerequisite Skills
